The following is an agreement between \_\_\_\_\_ and the Cumberland County College Commercial Driving School concerning the Commercial Driver Training Course.

The course is a 170 hour, 4 (concurrent) week curriculum consisting of classroom, range, and on the road driving. Each student will practice all maneuvers associated with deliveries and yard jockeying at the Bradway Trucking, Inc. range and terminal in Vineland, NJ. Students also receive on the highway and behind the wheel driving in city and country areas. The student will acquire enough experience and confidence to secure all licenses and endorsements to enter the workforce.

In order to cancel a lesson and reschedule that lesson, twenty four hours advance notice is required or the student may be charged for that lesson. Cancellation must be made at the phone number listed above. Because this course is a full time structured class, cancellation or re-scheduling of class or behind the wheel lessons is against school policy except for the following reasons: Absences due to illness, death of an immediate family member, or other unavoidable circumstance. Any circumstance of this nature must be reported to the school within twenty four hours of said incident. A doctor's note or other documented evidence shall be submitted to the lead instructor. Make up time will be arranged at the Lead Instructor's and school's convenience and mutually agreed upon by both parties. The number of hours per lesson specified shall be the actual number of hours of instruction provided to the student. The vehicle used for instruction shall have a manual gear shift and is equipped with a brake for the student and the instructor. No fees will be charged other than those specified on this agreement.

A student may rescind this agreement within seventy two hours of the first lesson of the course. Upon rescission, the student shall receive a refund for any lessons or services not provided. A minimum charge of \$500 will apply plus any applicable fees. (Example: physical, drug screen, permit, license fees, application charge, registration fees, etc.) Drop out refunds of tuition, plus applicable fees, will be the following: First or 2nd day \$2,985, First Week \$2,613.75, 2nd week \$1,742.50, 3rd week \$871.25, 4th week no refund. Completion of the week is defined as partially attending the Wednesday class.

No person shall be denied any opportunity or services including admission or graduation from this school because of race, creed, sex, sexual orientation, color, religion, national origin or physical disabilities\*. \*Must meet U.S. Department of Transportation physical requirements for commercial motor vehicle drivers.
